Introduction

This Open Call Guide is intended for young individuals aged 18–30 who are interested in participating in the Youth Living Labs training and innovation program. The guide provides an overview of the initiative, eligibility requirements, benefits, and instructions on how to apply.













About the Youth Living Labs Project

Youth Living Labs is a European initiative implemented across 5 countries, aiming to empower young people to become community leaders and innovators. By participating in the program, youth will develop critical personal, social, and technical skills to address societal challenges and improve their chances in the job market. The project supports the creation of local innovation hubs—called Youth Living Labs—where young people, businesses, and community stakeholders work together to co-create real solutions.













Program Overview

The program includes a structured training course, real-life innovation workshops, and continued engagement through the local Youth Living Lab. Participants will gain personal insight, build strategic and entrepreneurial competencies, and work directly with companies to solve real problems. The program is implemented by a consortium of expert organizations in youth empowerment, entrepreneurship, innovation, and sustainability.













Eligibility Criteria

To be eligible, applicants must:

- Be aged between 18 and 30
- Reside in one of the project's participating countries (Spain, Greece, Cyprus, Egypt, Jordan)
- Be interested in personal development, social innovation, or career empowerment
- Have basic knowledge of English
- Be available to attend the training and follow-up activities

No prior experience in business or community work is required. The focus is on attitude, motivation, and readiness to grow.

Eligible participants will be accepted on a first-come, first-served basis.
